



ANNEXURE 20

The below mentioned rules are imposed by the NBAA and are applicable for the Junior National Team Members

1. Team Captain

The team captain is nominated and then voted for by the team. All team members, including the reserve may vote. No team member may vote for themselves. Nominees may not vote. Once the team captain is announced the team members who did not vote for the team captain will accept the fact that majority rules and that a leader has been chosen. Team members are expected to show the respect due to the captain and to work with the captain and not against the captain.

2. Team Manager / Parents / Guardians

The team manager is appointed by the selection committee and the decision is ALWAYS made as who will benefit the team the most and to who is in fact available. Once the team manager is appointed the team is expected to show the respect due and to work with the team manager. Team manager positions can be filled by parents / guardians of junior team members. Parents / guardians of junior team members will be invited to attend the events even in a non-managerial capacity.

3. Team Meetings

Team meetings will be held prior to departure as well as at the venue, team members are expected to attend.

4. Team Clothing

Will be determined by the executive council of the NBAA and the team will be instructed as to what to wear when.

5. Boat Partners / Skippers:

Host countries provide fully rigged bass boats for the events skippered by experienced skippers. Junior anglers are not allowed to drive boats with the main motor. Boat pairings will be decided by the team captain.

6. General Behaviour:

Junior team members will be representing Namibia at international tournaments. Team members must behave in a cordial manner as instructed by team management or parents / guardians.
